Explanation of Responses:

The restricted stock units will vest one-third on the first, second and third anniversaries of the date of grant and the stock underlying the restricted units will be delivered on or within 30 days of June 22 of each year.
- Represents the sale of shares, pursuant to a 10b5-1 Sales Plan, adopted by the reporting person on August 16, 2022, to pay the tax liability incident to the vesting of RSUs.
- For each sale in this filing, the price reported in Column 4 is a weighted average price. These shares were sold in multiple transactions at prices ranging from \$13.29 to \$13.62, inclusive.
